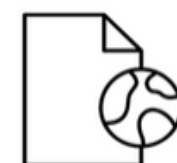
- Investment attractiveness increase of the Republic of Crimea, development of the international and transregional economic and cultural relations of the Republic of Crimea

FOUNDATION DOCUMENTS

- The Law of the Republic of Crimea "About the investment policy and state support of the investment activity in the Republic of Crimea" № 624-3PK / 2019 from July 2, 2019
- The procedure for considering investors' appeals, concluding agreements on the implementation of investment projects, monitoring of the agreement conditions accomplishment and the investment projects implementation, as well as supervision of the investment projects in the Republic of Crimea, approved by a resolution of the Council of Ministers of the Republic of Crimea № 368 from 07.10.2014
- Socio-economic development strategy of the Republic of Crimea, approved by the Law of the Republic of Crimea № 352-3PK/2017 from 27.12.2017



REGIONAL MEASURES OF THE INVESTMENT SUPPORT

- Functioning of the investment web portal of the Republic of Crimea
- Working out of the investment card of the Republic of Crimea
- Listing of the plots of land and real estate units for accomplishment of prospective investment projects and venues assortment is on way
- Leasing out of the plots of land and real estate units in the Republic of Crimea without tendering
- Providing with the information about the availability and condition of engineering infrastructure at the request of investors
- Forming up a working group (called "supervisors") from the representatives of the Executive Authorities of the Republic of Crimea to accompany the investment project

Property tax 0%

organization tax exemption for 10 years



Land tax 0%

organization tax exemption for 3 years



Reduced insurance rates - 7,6%

Retirement fund of the RF - 6%;

Social Insurance Fund of the RF - 1,5%;

Federal compulsory medical insurance fund - 0,1%



Income tax of 2%

Federal budget - 0% for 10 years;

Crimean budget - 2% during the first 3 years, 6% from the 4th to the 8th years, 13,5% from the 9th year
